On the Wings of Eagles

"But those who hope in the Lord will renew their strength. They will soar on wings like eagles; they will run and not grow weary, they will walk and not be faint." Isaiah 40:31

When I was growing up, you didn't see eagles in our area. You saw them on TV when there was a special on one of the national parks out west. But over the last 40 years, seeing eagles has become a regular occurrence in central Missouri. There is an eagle nest just north of California, right across from Bob & MaryAnn Kueffer's house. It's impressive to see the nest and eagles soaring over the fields and roads nearby. When I drove down to Humphrey's Creek Christian Church between Tuscumbia and St. Elizabeth, there was a big eagles' nest just east of the Highway 17 and Highway 52 junction. I would always slow down and try to see if the eagles were on the nest. It was exciting to see them.

Dad and I see eagles quite often when we are fishing at the Lake of the Ozarks. We've seen them dive down, scoop up a fish and then perch on a tree limb to devour their dinner. They seem to fly so effortlessly, even against the wind. They barely move their wings to change directions. They use the wind currents to soar and dive. It is a beautiful sight to see an eagle soaring high in the sky or up close and personal.

In chapter 40 of Isaiah, God is comforting his people. They are facing discouraging times. Their energy levels are dwindling and they are starting to give up hope. God is telling his people, that he is in control and he is the source of their strength. We need to look to him to provide the encouragement we need so desperately in a discouraging world. He tells the readers to look up to the heavens (v. 26) and he tells us that he carries us in his arms like a shepherd carries his lambs (v.11). How do we tap the source of this strength? He tells us in verse 8 "The grass withers and the flowers fall, but the word of our God endures forever."



There is power and encouragement in God's word but we have to access it and read it ourselves. When you are down and discouraged, read a Psalms, one of the gospels, or Revelation. It might take a little bit, but you will start to soar like the eagles high in the sky.

May is a wonderful month. Betty's birthday is on the 3rd. Her mom's and sister's birthdays are a few days later. My Grandpa Cobb would have been 102 on May 18th. My brother Matt's birthday is the 22nd. We have Mother's Day on the 14th and high school graduation on the 21st. We'll honor our 7 seniors that morning. We'll have our annual Memorial Day service at the church cemetery on May 28th. Lots of special celebrations to take place. I look forward to worshipping with you in May as we continue to go through the book of Isaiah. It's a wonderful time of year to be outdoors.


