Transformation Part Two

“If you declare with your mouth, “Jesus is Lord,” and believe in your heart that God raised him from the dead, you will be saved. For it is with your heart that you believe and are justified, and it is with your mouth that you profess your faith and are saved,” (Romans 10:9-10)

We continue our study of the book of Romans in July. We will cover chapters 6-10 in July. Paul has been writing to his Jewish brothers and sisters and telling them that faith in Jesus is the way to salvation. He has tried to describe the type of faith we must have by talking about Abraham in chapter 4. He constantly reminds them and us we are saved from God’s wrath because of the blood and death of Christ and that we have a new life to live for him in service to others. We’ll talk more about that in chapters 12-16 in August. I encourage you to read through the book of Romans this summer and watch the videos on Right Now Media that go even deeper into this great book of faith.

I want to say thank you to Ronda Mortenson and all of her helpers for Bible School. What a great group of kids and volunteers. They put in countless hours to make that week a wonderful experience of learning about God and his love for them. Studies continue to show that VBS is still a powerful outreach tool for youth learning about Jesus. I’m so thankful for our VBS leadership. Each Sunday has been a testimony to the musical talent we have in our church.

California United Church of Christ June 17, 2024 – Consistory Meeting Highlights

The June meeting of the California United Church of Christ Consistory was called to order by President Alan Chambers at 7:00 pm. The meeting opened with prayer led by Reverend Cobb.

The Minutes of the May meeting, the Treasurer's Report presented by Ellen Ash, Treasurer, (She noted that check # 1173 for \$7,626.00 was the final one for the repairs and painting Imhoff did to the wood areas around the sanctuary windows before the new frames and covers could go on. Check # 16360 for \$4,237.50 was a quarterly payment to Church Mutual, our insurance company.) the Financial Secretary's Report reviewed by Financial Secretary, Larry Schoeneberg, and the Stewardship Snapshot were all approved.

Worship Statistics were discussed. It is nice to have an on-line count listed in addition to in-person worshippers.

The only correspondence was a request to use the UCC hand bells for an event that none of the Church bell choir was involved in. The request was denied.

Building and Grounds - Jay Bestgen and Jim Deeken

Oak and North Street Window Covers - COMPLETE

SWC Camera and Access components are 99% complete. There is a text alert that would advise if a door was open-- that is not done. A monitor that records motion will run all the time. It is viewed only if there an incident.

Elevator valve/Head Space sign/Phone/ Leaking Hydraulic Storage Tank.

The custom built elevator valve has arrived but is not yet installed. The "No Head Space" sign is a lower priority. There will eventually be a phone in the elevator per regulations. The hydraulic oil storage pan has a leak and will be repaired.

Light Switches in the Sound Room off of the Friendship Hall- COMPLETED

Twenty new light switches have been installed. 500 watt bulbs were converted to 35 watt LED bulbs. The lift required a new battery (\$150.00) before the project could be completed. There are new lights in the stage area.

Gas Stove Control Protective Cover—COMPLETED

Carpet for Office - COMPLETED Carpet for the second office will be done in the future.

Church Mutual Insurance- Jim Deeken-No word on original question of coverage. Now there is a need for a certificate to include the copier in the coverage and Church Mutual does not respond to email, texts, or calls.

Evangelism-Holly Bieri-Ginnie Medlin leads the committee- Committee members handed out jerky to fathers for Father's Day. (There is no relation between jerky and fathers. Jerky is just a yummy treat!)

Committee sought approval for a T-shirt design representing our congregation (there will be multiple styles available) Consistory approval unanimously given. Committee will participate in the 4th of July Parade. (Bring in those big bags of candy! God always gives gifts in abundance!) A new church directory is in the future plans.

Worship - VanDee Miller - Summer music is scheduled; the Father's Day background was available for photos.

SWC Go Live Date and Distribution of Fobs Follow Up-The go-live date was June 3, 2024. Fobs have been distributed and are in use. Confusion over where to "fob" alleviated by a sign.

Memorial Fund-suggestion of electronic sign in front of church-Still need more examples of electronic signs in use to determine most effective design for our Purpose (If you see one you like take a picture and send it to a Consistory member.)

New Business

Memorial Fund Request for Photo Backdrops and Stand- Committee Member, Beth Dampf, took the lead and informed each committee member of the need, the use, and of the cost of the project (\$125.00). An e-mail or phone vote was taken. There was unanimous support for the project. (Project completed and used Father's Day.)

SWC Fob Quote--Issued 71 of 100 Fobs to Date- There will be a need for additional fobs. 100 additional fobs will be purchased (They come only in increments of 100.) with money coming from the Building Fund.

EasyTithe Migration to Amplify- This is a name change only and in no way affects any aspect of e-giving. The name change to Amplify will occur in November.

Special Benevolence—July

RAPE & ABUSE CRISIS SERVICE (RACS)

The special benevolent mission project for July is the Rape and Abuse Crisis Service (RACS). RACS is a non-shelter, social service agency providing crisis intervention, advocacy, support and education/prevention services to victims/survivors of sexual assault, domestic violence and stalking. **RACS** began its mission in early 1980 by establishing a 24-hour crisis hotline to offer emotional support and referral information to victims of domestic violence and sexual assault. Nine central Missouri counties are served by RACS including Cole, Gasconade, Maries, Miller, Moniteau, Morgan, Osage, Southern Boone and Southern Callaway. The agency continues to evaluate the services provided in order to more effectively address victims' needs. Services have gradually expanded as needs and funding for this not-for-profit agency have increased. The services they provide are free of charge to people who have been victims. They also provide education and prevention programs to end personal violence in our society. Providing victims with the opportunity to regain confidence, control and direction in their lives helps keep this community strong. Please give to the important mission in the attached envelope.

UCC Brotherhood Minutes – Monday June 24, 2024

The meeting was held at First Christian Church due to ongoing Vacation Bible School at UCC California. Many thanks to Pastor Kevin King for allowing the Brotherhood to use the facilities.

Refreshments – President Dave Meyer provided a delicious meal and desserts to begin the meeting and Larry Schoeneberg prayed a blessing over the meal.

Following refreshments, Larry Rohrbach gave a devotion around Galatians 6:9 “Let us not become weary in doing good, for at the proper time we will reap a harvest if we do not give up.” He remarked that it is apparent that although Man’s wisdom just isn’t very good, but we are still here, we are still worshipping God, and change will come if we do not give up.

Business Meeting – President Dave Myer called the business meeting to order at 7:40 PM with 16 members and guests present. The minutes of the May meeting were approved by acclamation.

The Treasurer’s report was approved with a current balance of \$3222.00 following a collection of \$128.00 at the April meeting and an approved donation of \$400 to Christian Veterinary Missions. A motion was approved for the Brotherhood to cover the cost of fish for the Vacation Bible School Fish Fry. Rob Barbour and Bob Kueffer will assist Tony Barry in frying the fish.

Thank you notes to the Brotherhood were presented from the UCC Worship Committee for singing during Lent and from Nancy Krutzsch for hosting her presentation about Christian Veterinary Missions.

A brief discussion was held concerning the next Brotherhood Family Night. An October date was discussed, but the decision was made to schedule it in November to avoid conflict with the Sunday School Fall Party. Further discussions will be held at subsequent Brotherhood meetings.

The July meeting will be held on July 22. John Osborn will provide refreshments, Lashley Rohrbach will give the devotion, and Alan Meyer will present about the activities of the Knights of Columbus. The annual Brotherhood fish fry will be held on August 26 in lieu of the regular meeting.

The business meeting adjourned at 7:55 PM.

Program – Pastor Kevin King of First Christian Church of California (Disciples of Christ) spoke about his lifetime faith journey and his long and roundabout path to becoming a pastor.

Kevin was raised near Marshfield, MO (near Springfield) in a primitive Baptist church and initially gave his life to Christ as a 12-year-old. He began singing in church and music continues to be a big part of his life. As a teenager, he rebelled against his faith and family and left home halfway through his senior year of high school and moved in with a friend whose father was a Disciples of Christ Minister. He later reconciled with his family and went to Stephens College where he received a degree in musical theater. He briefly worked in the acting field, and then began teaching and coaching debate at North Callaway, Lebanon, and Marshfield High Schools.

During this time, however, he remained away from his faith. He began praying and attending church regularly when his wife became pregnant with their first child. He heard God's call to the ministry at that time, but he resisted. He fell away from his faith again when he and his wife divorced. He began attending church again when he met his current wife, who lived in California, and he decided to answer the call to ministry.

He became a pastor of a Presbyterian church, but Satan attacked, and he was forced to leave that ministry due to theological disagreements with the denomination. At the same time, he was removed from his debate coach position at Marshfield High School because of, in part, his ministerial aspirations. He persevered, however, and began teaching and coaching again at Russellville High School. He was soon asked to fill in as pastor at Community Christian Church in Jefferson City and he moved to California. He was a member of First Christian Church and became youth pastor, working with Pastor Alan Bailey. When Pastor Bailey left, he became pastor and has been in that position for about a year and a half. During that time, he has introduced a Spirit-led ministry and attendance has increased dramatically. In addition to being a pastor, he currently teaches English and Theater at Eldon High School. He professes that sometimes God has to allow us to be uncomfortable to get us to move according to his plan.

Meeting adjourned at 8:45 p.m.



