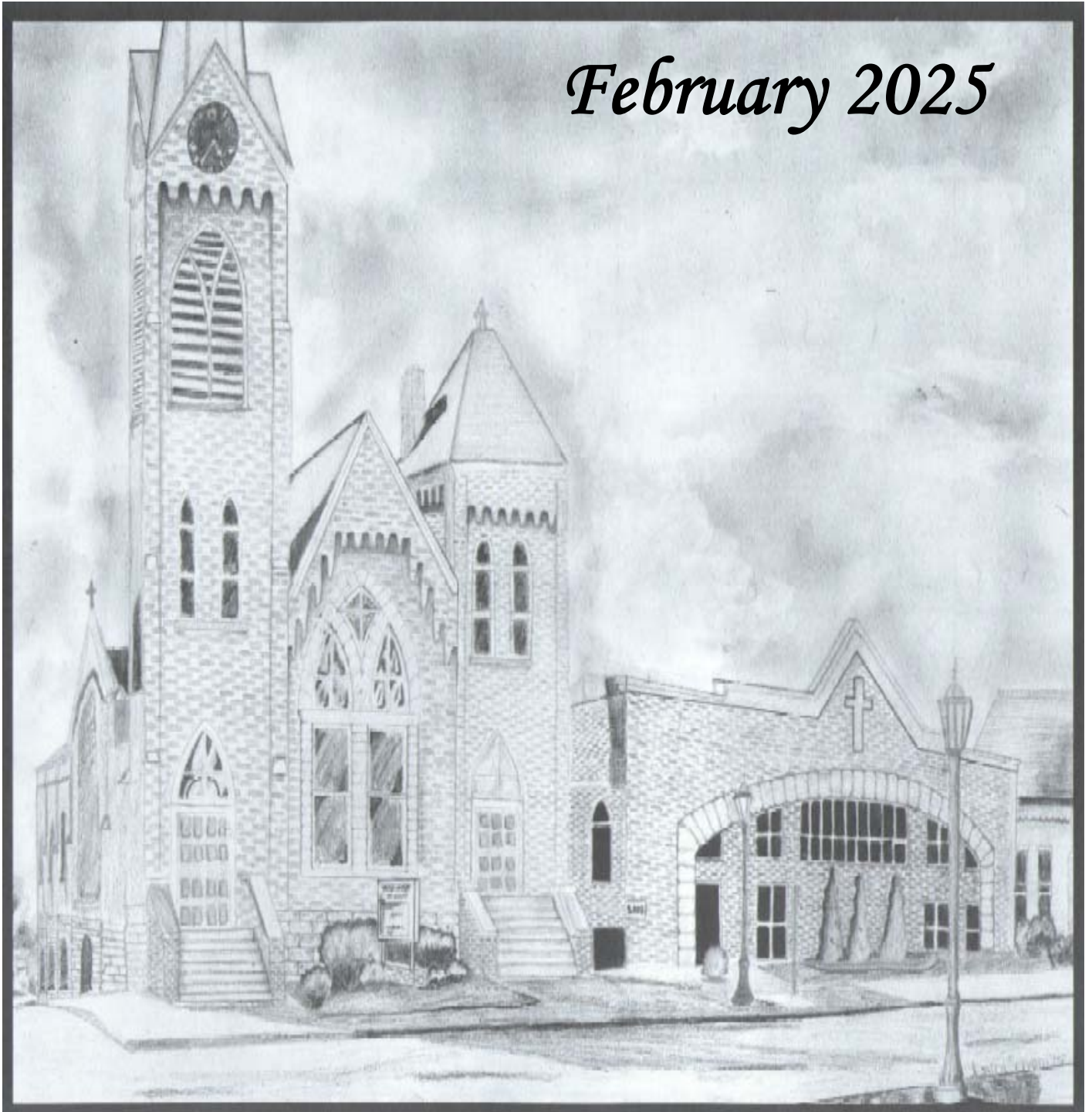

“To be made new in the attitude of your minds; and to put on the new self, created to be like God in true righteousness and holiness.” (Ephesians 4:23-24)

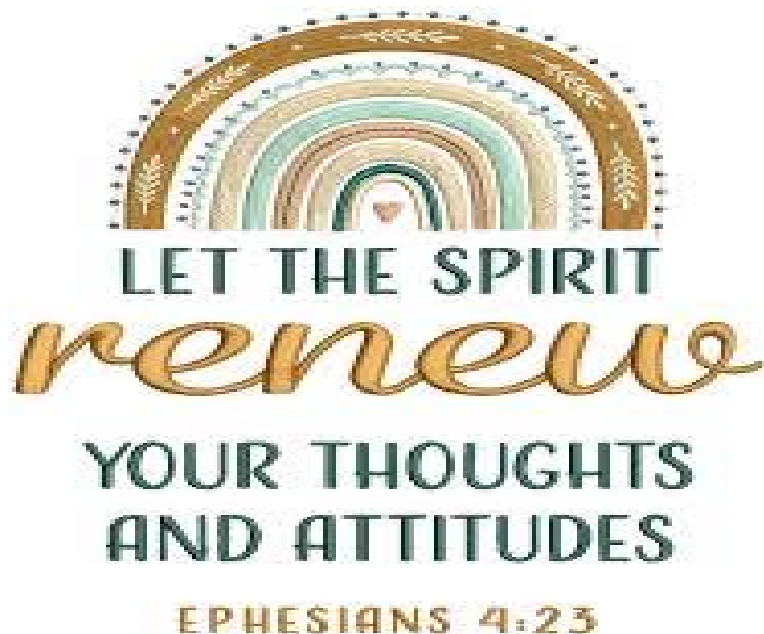

The January meeting of the California United Church of Christ was called to order at 6:03 by President Alan Chambers. Reverend Cobb opened the meeting with prayer. A quorum was established with Carole Barbour, Jay Bestgen, Holly Bieri, Alan Chambers, Jim Deeken, and Larry Schoeneberg attending. Absent were Ellen Ash and VanDee Miller.

Minutes of the December Meeting were approved along with the Treasurer's Report and Financial Secretary's Report, and Stewardship Snapshot (Larry Schoeneberg). In the check detail there were two checks of special interest: a check to Insurance Board for a quarterly payment of \$4,975.25 and a check to All Rise Elevator Company for inspection of the church elevator for \$1,150.00. There was no CD Activity.

Holly Bieri, Local Benevolence Chair, noted that there was activity in the account and one individual had been assisted.

Correspondence included many thank you notes and an e-mail that suggested a set time for Communion each month might be a possibility. This will be a point of discussion at another time.

Building and Grounds/Safe Church - Jay Bestgen and Jim Deeken Elevator Update--State Inspection and State Testing successfully completed.

Leaks in Second Floor Classrooms on West side--Due to weather and sleet/snow accumulation an ice dam formed that caused what melted to run under the shingles and eventually into the classrooms. Carpets have been pulled up, fans put into the affected areas, and plastic sheeting taped in place to collect the melting snow/ice as the thaw continues. The committee will be looking at future prevention and repair in the immediate future.

Local Benevolence Fund

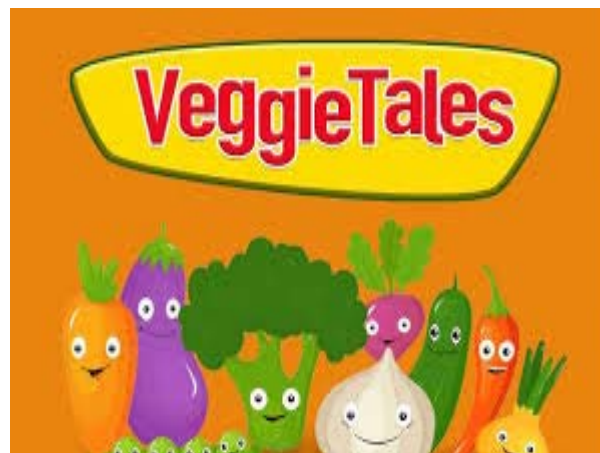

UNITED CHURCH OF CHRIST OF CALIFORNIA FIRE AND EMERGENCY EVACUATION PROCESS

1. In the event of a fire or other emergency evacuation, infants and toddlers in the church nursery will be taken by the nursery attendant, nursery volunteer, and designated Consistory usher member to the south parking lot between the United Church of Christ of California and the United Methodist Church. Parents of the nursery children should meet their children in this parking lot.
2. If the nursery is being used for special events, the nursery attendant(s) will take the children to the south parking lot between the United Church of Christ of California and the United Methodist Church. Parents of the nursery children should meet their children in this parking lot.
3. In the event of an emergency evacuation, all other children who are not with their parents, and not in the nursery, will be escorted out of the building by the volunteers or church staff who are currently in charge of them. They will be escorted to the south parking lot between the United Church of Christ of California and the United Methodist Church. Parents of the children should meet their children in this parking lot.
4. All others in the church facility need to leave in an orderly fashion and gather in the south parking lot between the United Church of Christ of California and the United Methodist Church.
5. If an individual is in a wheelchair and they are not on the main floor in the case of an emergency evacuation, **DO NOT USE** the elevator. All adults in the area who are capable of moving the individual and wheelchair outside or to the main floor need to assist immediately.

- *Library
- *Sound Room in the Friendship Hall
- *North wall in the Fellowship Hall

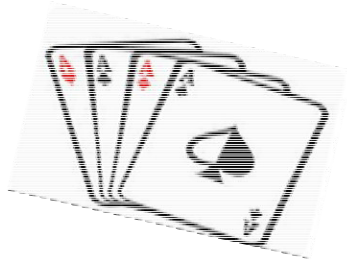

Missouri Mid-South Conference and Western Association update

The Missouri Mid-South Conference held a Special Meeting on Saturday, January 11, 2025, via zoom. Larry Rohrbach and Carla Clennin attended. This special meeting was held due to items from the original Conference Annual Gathering (CAG) on October 19, 2024, and was cut short as an objection was raised that the conference by-laws were not properly followed in nominating Rev. Nelson. This action was removed from the agenda. An objection was also raised that the by-laws were not followed to nominate new members on the Board of Directors and this item was removed from the agenda. The special meeting was called to order at 10 AM by Dr. Duana Russell-Thomas, Board Chair. A quorum was established that there were 70 churches and 142 clergy and delegates present. The following two items were approved: 1) Slate of Delegates to General Synod Class of 2025 and Class of 2028; 2) Board of Directors for 2024-2025 w/out a Treasurer and Assistant Treasurer (to be filled from St. Louis Assn.) Dr. Russell-Thomas did state they had someone in mind for Treasurer just no commitment prior to meeting.

Next agenda item was *“Resolution to Ratify Conference Minister Search and Call Process for the Missouri Mid-South Conference of the United Church of Christ”*. There were several attendees that spoke “Pro” then would go to a “Con” then go to a “Neutral”; each person had 2 minutes to speak. After about 30 minutes a vote was called. First vote was 55 Yes; 70 No; 10 Abstained; Motion failed. Someone raised a question if there was still a quorum, and the visitors were not sent to the proper room to not vote it was determined there was a quorum another vote was taken. 50 Yes; 68 No; 8 Abstained; Motion failed. The business meeting ended. Dr. Russell-Thomas stated that the Board will now discuss what to do next at their February Board meeting.
