The March meeting was called to order at 6:00pm by President Carole Barbour. Reverend Cobb opened the meeting with a prayer. A quorum was established with Carole Barbour, Jay Bestgen, Holly Bieri, Jim Deeken, Ellen Ash, Larry Schoeneberg, Anny Roll, and Kris Ingram present.

Minutes of the February Meeting were approved along with the Treasurer's Report given by Ellen Ash and the Financial Secretary's Report and Stewardship Snapshot given by Larry Schoeneberg. Emmaus Homes - Easter Sunday Benevolence

Emmaus Homes was founded in 1893 in Marthasville, Missouri, by our antecedent denomination (The Evangelical Synod) when they decided to use their vacated seminary buildings to serve individuals with developmental disabilities. As a reflection of their Christian faith, the founders of Emmaus attempted to care for those in need, while recognizing each person's worth and unique qualities and by creating a spirit of community. In 1901, Emmaus opened its St Charles campus to meet the vast need for services to people with developmental disabilities closer to St. Louis. Today, while some individuals still reside on the Emmaus campuses, many now live in homes in the community. Emmaus serves clients in nearly 50 homes throughout the St. Charles, St. Louis, Warren and Franklin counties and St. Louis City. Emmaus works with each client to help them live as independently as possible.

Arising from faith in Jesus Christ, the mission of Emmaus Homes is to enhance the quality of life for adults of all beliefs who have cognitive, intellectual, and other developmental disabilities. The individual's mental, physical, and social abilities are assessed to determine the living situation best suited to their needs, including on campus housing, group homes and individual supported living residences. Some homes have 24-hour supervision, while others provide part-time supervision and assistance.

At Emmaus, an individual's spiritual life is an important part of one's journey to fulfillment and independence. Emmaus takes pride in their faith-based heritage, and strives to help each of their clients participate in the faith community of their choice. Ordained ministers and seminary students help guide and encourage their clients of all beliefs in their spiritual pursuits. A variety of spiritual care services are provided to clients, family members, and staff.







Refreshments – Larry Rohrbach provided a delicious meal to begin the meeting and Allan Mortenson prayed a blessing over the meal.

Following refreshments, Dave Meyer gave a devotion around Jesus's temptation in the desert. He remarked that Jesus rebuked Satan and showed dominion over him, and that is an example for us to follow. Jesus gave us the playbook, what are we waiting for?

Business Meeting – Incoming President Larry Rohrbach called the business meeting to order at 7:48 PM with 23 members and guests present.

Dave Gattermeir read the minutes of the February 27, 2025 meeting, which were approved without revision.

Tony Barry gave the Treasure's report. As of January, 2025, there was \$2375.22 in the Brotherhood account. Offerings were \$285 at the January meeting and \$180 at the February meeting, for a current balance of \$2840.22. No disbursements were made in January or February.

A motion was made and passed to authorize Steven Burger to donate up to \$600 from the Brotherhood to Operation Save the Smokies after he follows up with Tara Farmer to determine the extent of the organization's need.

The Brotherhood chose "Search Me, O God" as the special music to be sung at the Lenten service on March 26, and the song was practiced.

Larry Schoeneberg and John Osborn volunteered to provide the meal at the April meeting, and Allan Mortenson volunteered to give the devotion. The program was tentatively set to be presentations by the Church's high school seniors. Pastor Cobb will touch base with the seniors to confirm that the date is OK.

The business meeting adjourned at 8:13 PM.

Program – Jason Ashley of Clarksburg spoke about his ministry, Recovery World Ministry, which provides drug and alcohol addiction recovery support through Destiny Pointe Church in Columbia. Jason is a recovering addict himself and is a certified Peer Support Specialist. The ministry meets every Tuesday night and with 40-100 people in attendance. It is a hybrid program based on Alcoholics Anonymous 12-step program with additional spiritually based components. Meetings normally consist of a message given by one of the Church's pastors, deacons, or elders, lessons on various aspects of recovery, and prayer.

Jason has been working to establish a branch of the ministry, called Free Indeed Recovery Ministry (FIRM) in Moniteau County. The group currently meets at Mt. Pleasant Baptist Church in Clarksburg, and he is looking to work with additional churches in the area.

Long-term, Jason hopes to establish a halfway home for recovering drug addicts, to be called Common Ground. The program would be 1 year in length and would be available to recovering addicts coming out of treatment centers or other institutions. It will focus on accountability, service and leadership, and stewardship.
