California United Church of Christ April 14, 2025 – Consistory Meeting Highlights

The April meeting was called to order at 6:00 p.m. by President Carole Barbour. Reverend Cobb opened the meeting with a prayer. A quorum was established with Carole Barbour, Jay Bestgen, Holly Bieri, Jim Deeken, Ellen Ash, Larry Schoeneberg, and Kris Ingram present. Anny Roll was absent.

Minutes of the March Meeting were approved along with the Treasurer's Report given by Ellen Ash and the Financial Secretary's Report and Stewardship Snapshot given by Larry Schoeneberg. In the check detail there were several items noted: Check 1038 to Dyan Ingram in the amount of \$375 for reimbursement of women's conference cost. Check 16630 to Insurance Board in the amount of \$4,975.25 for the quarterly insurance payment. Check 16643 to Allan Mortenson in the amount of \$2,055 for the upgraded office computers. Check 16649 to George B. Kavanaugh in the amount of \$510 for spring maintenance on the organ. Check 16656 to Michael Butterworth in the amount of \$390 for tuning 3 pianos. It was noted the total expenses for the month of March 2025 compared to March of 2024 were up by \$9,492.22; the increase in expenses was due to an increase in the quarterly insurance payment amount and the cost of upgrading the office computers.

Correspondence included a thank you note from Alan Chambers and a letter with a generous donation for the stain glass window restoration project from Keith and Paula Selk.

Beginning <u>Sunday, May 4th</u>, the Sacrament of Holy Communion will be on the first Sunday of each month.








