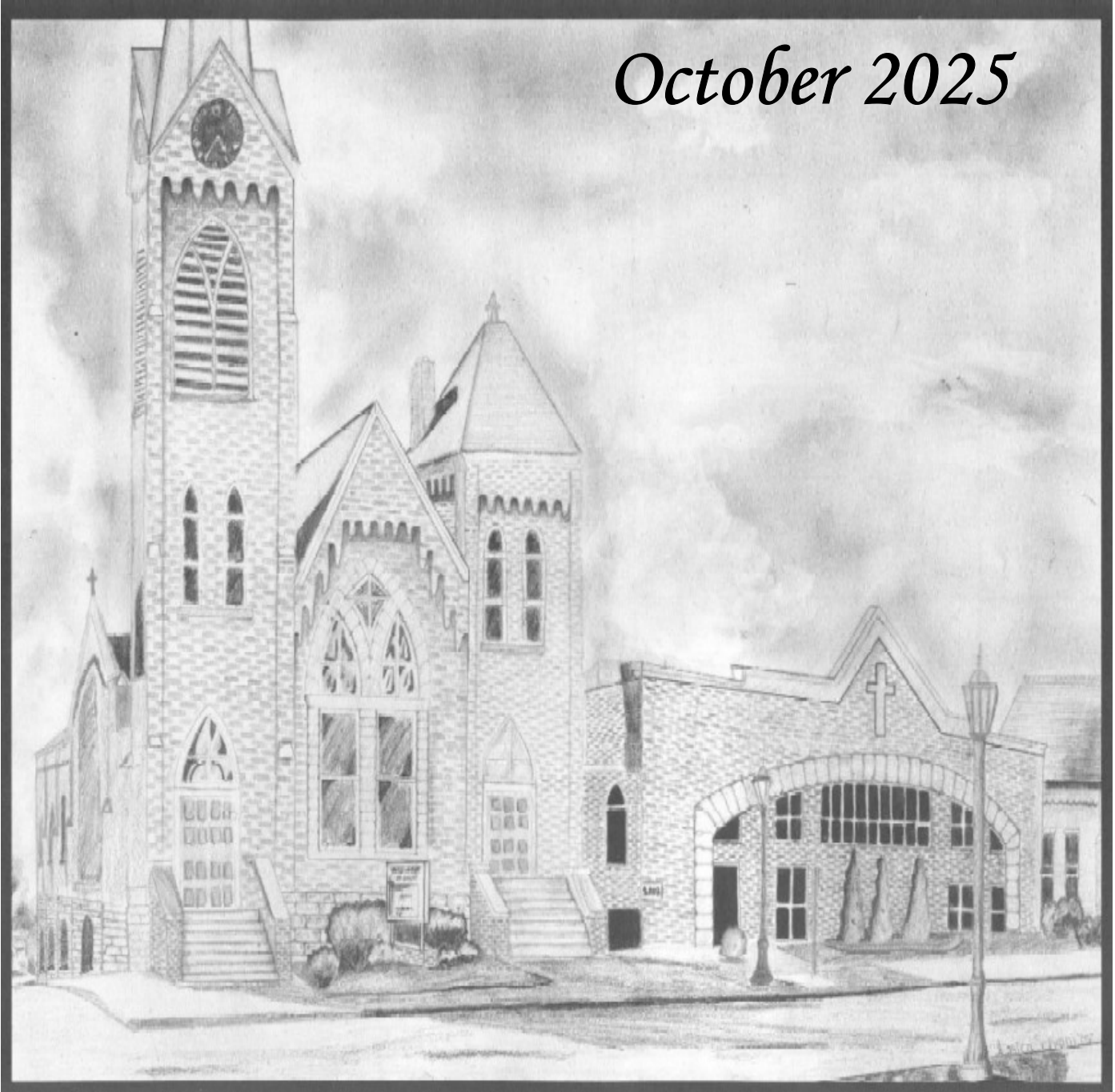

September 8, 2025 – Consistory Meeting Highlights

The September meeting was called to order at 6:00pm by President Carole Barbour. Reverend Cobb opened the meeting with a prayer. A quorum was established with Jim Deeken, Jay Bestgen, Holly Bieri, Larry Schoeneberg, Carole Barbour, and Kris Ingram present. Anny Roll was absent. Kenny Wolken from Salem UCC was a special guest.

Treasurer, Ellen Ash presented the Treasurer's Report and the Stewardship Snapshot Report. The balance brought forward in the General Fund was \$26,427.28. There were \$22,324.59 in receipts and \$24,616.08 in disbursements with a balance of \$24,135.79. Several checks were noted: Check #1186 to Taylor Hampton in the amount of \$2,355.52 for painting Fellowship Hall, Check #1187 to K.A. Dutcher Paint in the amount of \$5,152.83 for paint and carpet used in the Fellowship Hall Revamp, Check #1188 to H&D Heating in the amount of \$1,310 for heating and cooling maintenance, Check #1189 to Environmental Engineer in the amount of \$1,210.56 for boiler maintenance, and Check #16797 to Megaphone Designs in the amount of \$850 for annual internet maintenance.

Financial Secretary, Larry Schoeneberg presented the Financial Secretary Report. The total income year to date is \$163,837.53 which is down from the same time last year. The total expenses year to date is \$194,215.67 which is up from the same time last year.

Larry Schoeneberg also gave an update on current CD activity. On August 27, 2025 \$29,000 from the UCC Church General Account was re-invested for 6 months with Bank of America Charlotte, NC at a rate of 4.05%. Also on August 13, 2025 \$100,000 from the Carmen Schnuck Endowment was re-invested with Bank of America at 4.05% for 12 months.

A thank you note was received by The California Fire Department thanking the church for their donation.

Committee Reports

Building and Grounds/Safe Church – Jay Bestgen, Jim Deeken, and Kris Ingram

Stain Glass Window Project – Brady's Window and Glass continues to work on the stain glass windows in need of repair and/or stabilization.

Revamping Fellowship Hall – New blinds have also been installed and the project has been completed.

Deep Cleaning – Mint Professional Cleaning will continue with striping and waxing the rest of the tile floors downstairs on September 18th and 19th. Work to fix the water damage in upstairs Sunday School Classroom will begin on September 9th.

Old Business

Sound booth – Jess Medlin has come forward to help in the sound booth. He will be trained and added to the scheduled rotation.

New Business

Nominating Committee - The Nominating Committee (Kris and Dyan Ingram, Anny Roll, Kendra Hall, and Kent Howard) will set a date to meet and start looking for people to fill open committee terms.

Mileage for Guest Pastors – The Consistory will take into account mileage in addition to the regular compensation for guest preachers. Mike Williams will be paid mileage for September 7th.

Nursery Attendant – Emma Bestgen was approved as the new Nursery Attendant.

Special Benevolence— October



The Salvation Army of Jefferson City, Missouri

The benevolence offering for the month of October is the Salvation Army Center of Hope. The Center of Hope is an emergency shelter for homeless men, women, and parents with children. It is the only shelter in the Jefferson City area that accommodates and can house all these groups, including veterans and senior citizens.

The Center of Hope Emergency Shelter provides social services that include a food pantry, clothing vouchers for the Salvation Army Thrift Store, Thanksgiving and Christmas dinners, Christmas assistance for food and toys for families, Christmas and Easter gifts for nursing home residents. Additional services available to help the homeless or near-homeless are the Pathway for Hope Program, rent and utility assistance and a permanent housing program. There are services specifically for children, such as free scouting programs, summer camps, kids choir and Christmas Kids.

The Salvation Army Corps provides Sunday School for all ages on Sunday at 10:00 a.m. and regular worship service on Sunday at 11:00 a.m. Please prayerfully consider giving to this worthy Christian cause.



UCC Brotherhood Minutes – Monday, September 22, 2025

Refreshments – Larry Rohrbach and Brandon Embry provided a delicious meal to begin the meeting, and Allan Mortenson prayed a blessing over the meal.

Following the meal, President Larry Rohrbach called the business meeting to order at 7:35 with 19 members and guests present.

Secretary Dave Gattermeir read the minutes from the August 28, 2025 meeting, which were approved without correction.

Treasurer Tony Barry reported that the Brotherhood account balance was at \$2,513.22 at the July meeting, and \$225 offering was collected. There was no collection at the August meeting. The current account balance is \$2,738.22 pending an unpaid \$164.00 bill for fish for the Vacation Bible School fish fry. The Brotherhood will also supply fish for one of the meals for the inmate's ministry.

Correspondence included fundraising literature from Hope for Caribbean Kids and the Central Missouri Food Bank.

Vice President Rob Barbour reported on the ongoing inmate's ministry. The UCC Women's Guild provided lunch on Monday for 21 inmates, support staff, City of California employees, and volunteers. The inmates worked on cleaning and maintaining the city ball fields and Proctor Park. The Brotherhood will provide a fish fry lunch on Wednesday September 24 and provide drinks, side dishes, and desserts throughout the week.

Holiday activities were discussed. The Brotherhood plans to put up Christmas decorations prior to the November 24 meeting, pending approval by the Consistory. Christmas caroling is planned for December 15 in lieu of the December meeting. Details will be discussed at future meetings.



The program for the October meeting is planned to be another visit from Greg Morrow, who spoke at the July Brotherhood meeting and who has now returned from Ukraine with new updates on the situation in the war-torn country.

The business meeting was adjourned at 7:54 PM.

Following the business meeting, Immediate Past President Dave Meyer gave a devotion on the enthusiasm he witnessed at the recent Missouri-Kansas football game, encouraging us to have that same enthusiasm for Team God, who has played at the same location since the beginning of time, has an unblemished winning record, and has a quarterback (Jesus) who resurrected his career like nobody in history. He quoted James 5:7-8: “Be patient, then, brothers and sisters, until the Lord’s coming. See how the farmer waits for the land to yield its valuable crop, patiently waiting for the autumn and spring rains. You too, be patient and stand firm, because the Lord’s coming is near.”

Program – California Postmaster Russ Nelson spoke on his work for the US Postal Service. Russ has been Postmaster for about 1 year after 18 years as a mail carrier in Columbia and work at many post offices around central Missouri. He is a strong Christian and prays daily for both his employees and customers. He explained that mail from California is picked up each morning and transported to Columbia, sorted, and then transported to processing centers in Kansas City or Saint Louis for distribution all over the world. Similarly, incoming mail is processed and sorted in Kansas City or St. Louis, sent to Columbia, and distributed across central Missouri, presorted by address. The California Post Office has 10 routes and delivers approximately 6000 pieces of mail daily. The US Postal Service also serves as the “last mile” delivery service for Amazon.com, delivering about 150 packages daily in California, which approximately doubles during the holiday season.

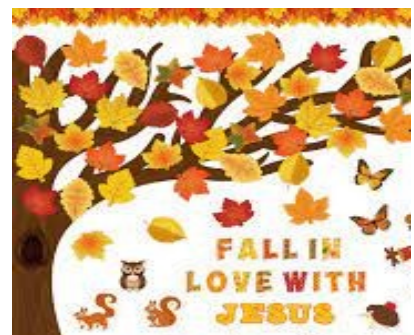


Middle School Youth Fellowship

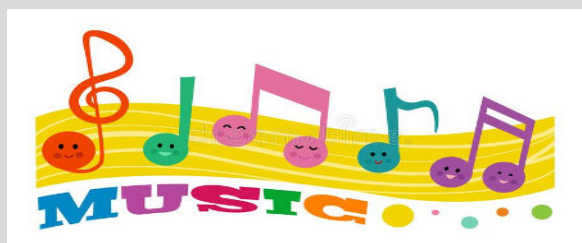

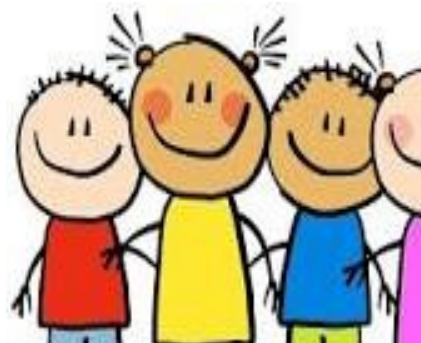

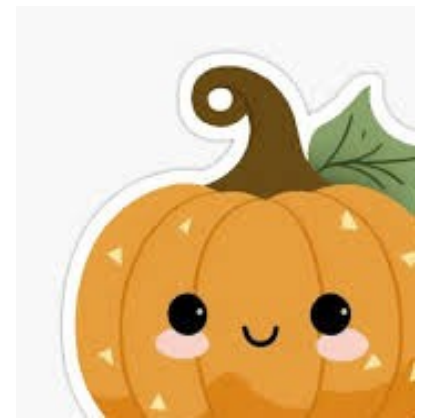
